## School reopening: risk assessment

*(with effect from Monday 8<sup>th</sup> March 2021)*

The second column now lists the control measures previously in place, as well as additions/changes for full reopening (we've also explained those additions/changes in the third column).

The measures we list are based on current (as at 24 February 2021) government guidance:

### How to approach risk estimation and management

The DfE advises that you take the following approach (in this order) to reducing risks in your school:

1. **Elimination:** if an activity isn't considered essential and has risks attached, stop it
2. **Substitution:** replace the activity with one that reduces the risk. Take care not to substitute the activity with one that'll introduce new hazards
3. **Engineering controls:** introduce measures that help control or mitigate risk
4. **Administrative controls:** identify and implement the procedures to improve safety (for example, by having markings on the floor or signage around school)
5. Having gone through this process, **use PPE where the guidance advises it is required**

### RAG rate your control measures

Mark up each control measure in the appropriate colour:

- > Red: this measure cannot be put in place in our school
- > Amber: this measure isn't in place yet, but can be put in place
- > Green: this measure is already in place

<p><b>Contact with someone suffering from coronavirus</b></p>	<p>Everyone will be asked not to come into school if they need to self-isolate under <a href="#">current government guidance</a>. Regular reminders will be given about this.</p> <p>If pupils or staff have travelled abroad, they will be asked not to come into school and to quarantine under the <a href="#">current government guidance</a>.</p> <p>Anyone self-isolating with symptoms will be advised to do so in line with current government guidance, and to access <a href="#">testing</a> and engage with the NHS Test and Trace process.</p> <p>If a symptomatic person comes into school or develops symptoms while in school, they will be sent home immediately or isolated until they can be picked up. <i>People will be isolated in the disabled toilet, as it is close to the front door and easily cleaned.</i></p> <p>999 will be called if they are seriously ill or injured or their life is at risk.</p> <p>In the case of a pupil who needs to be supervised before being picked up:</p> <ul style="list-style-type: none"> <li>• A window will be opened in the room to allow for fresh air ventilation</li> <li>• If a distance of 2 metres can't be maintained, supervising staff will</li> </ul>	<p><b>Pupils or staff that have travelled abroad:</b> you need to point them to the <a href="#">current government guidance on quarantine</a> and they must not come into school.</p> <p><b>Contact with a symptomatic pupil or pupil who has a positive test at school:</b></p> <p>In exceptional circumstances, if parents/carers cannot collect their child and they agree it's age-appropriate and safe to do so, the pupil can walk, cycle or scoot home.</p> <p>If you need to make alternative arrangements to transport them home:</p> <ul style="list-style-type: none"> <li>• Your local authority may be able to source a suitable vehicle to transport the pupil</li> <li>• You must inform the driver that the pupil has developed symptoms/tested positive</li> </ul> <p><b>Rapid testing programme:</b></p> <p>We are a <b>primary school</b> participating in the government's rapid testing programme, there are no changes to the arrangements. 	<p>helpline on <b>0800 046 8687</b> and select option 1. (If no advice is required, the school will report the case using the DfE's '<a href="#">online attendance form daily return</a>'). The advice service (or <a href="#">local health protection team</a>, if the call is escalated to them), will carry out a rapid risk assessment to confirm who's been in close contact with the person when infectious.</p> <p>The school will ask (using a template letter from the local health protection team) all close contacts to self-isolate in line with current government guidance.</p> <p>If there are 2 or more confirmed cases within 14 days, or an overall rise in sickness absence where coronavirus is suspected, the school will work with the local health protection team, who can be reached by calling the DfE helpline and selecting option 1, to decide if additional action is needed. <p><b>Contact with coronavirus when getting to and from school</b></p>	<p>Everyone will be encouraged to walk, cycle or scoot into school, and asked to avoid taking public transport during peak times if possible. Bike storage is available on site and there will be staggered start and collection times to help pupils and parents during peak times.</p> <p>Anyone who needs to take public transport will be referred to <a href="#">government guidance</a>.</p> <p>Parents/carers who need to drop off and pick up pupils will be told through messages and signage.</p> <p>The protocols for minimising adult to adult contact. At Hardwick we are using:</p> <ul style="list-style-type: none"> <li>• Different entrances and exits</li> <li>• Allocated drop off and collection times</li> <li>• Parents of KS2 pupils are to wait (socially distanced) on the green by the school and the pupils bring themselves onto the school site.</li> <li>• One EYFS parent to bring their child to the classroom gate and then leave</li> <li>• One KS1parent to queue on the spaced markings on the playground</li> <li>• Only one parent/carer should attend site</li> <li>• Parents asked not to gather at entrance gates or doors, or enter the site unless they have a pre-arranged appointment</li> </ul>		<p>Staff Parents Pupils Visitors</p>	<p>From 8<sup>th</sup> March 2021</p>	<p>Staff and visitors can provide their own face covering and the school office has a supply if someone hasn't got a face covering.</p>

<p><b>Face coverings in school</b></p> <p>Staff and visitors will be asked to keep on or put on a face covering when arriving at school and moving around indoors in places where social distancing isn't possible, such as corridors and communal areas, unless they're exempt from wearing one. They will be asked to wash their hands before and after putting on or removing a face covering.</p> <p>Parents/carers and children over the age of 12 will be asked to wear a face covering whilst on site at drop off and collection times.</p> <p>A supply of spare face coverings will be kept for any staff member or visitor who arrives without one or has one that's unsafe to wear.</p> <p>Anyone wearing reusable face coverings when arriving to school will be expected to bring a plastic bag to keep these in during the school day when not in use. Disposable face coverings will be disposed of in a covered bin.</p> <p>Any pupil wearing any sort of face covering when arriving to school will wash their hands on arrival (as all individuals will), dispose of/store the covering, and wash their hands again before going to their classroom.</p> <p>Everyone will be made aware that they mustn't touch the front of the covering during use or removal.</p>	<p><b>Face coverings:</b></p> <ul style="list-style-type: none"> <li>• In primary schools, it's now recommended that staff and visitors wear face coverings where social distancing between adults isn't possible (e.g. corridors and communal areas)</li> </ul> <p>We have allowed staff to make their own decisions on wearing a face covering in classrooms, depending on their own situation (e.g. being clinically vulnerable). These staff may be wearing a face covering at all times whilst in school</p> <p>We have asked staff to wear a face covering if they cannot socially distance with other adults in the same room (e.g. in group work rooms, school office)</p> <ul style="list-style-type: none"> <li>• Only essential visitors can come into the school building by appointment only and must wear a face covering at all times whilst in the building.</li> </ul>

<p><b>Spreading infection due to touch, sneezes and coughs</b></p>	<p>Handwashing facilities will be provided. Hand sanitiser is at the main entrances and exits to the school and in rooms we use.</p> <p>Everyone in school will:</p> <ul style="list-style-type: none"> <li>• Frequently wash their hands with soap and water for 20 seconds and dry thoroughly using <a href="#">NHS guidelines</a>, or use alcohol-based hand sanitiser to cover all parts of their hands</li> <li>• Clean their hands on arrival, after breaks, if they change rooms, before and after eating, and after sneezing or coughing</li> <li>• Be encouraged not to touch their mouth, eyes and nose</li> <li>• Use a tissue or elbow to cough or sneeze, and use bins for tissue waste</li> </ul> <p>Pupils will be encouraged to learn and practise these habits in lessons and by posters put up across the school.</p> <p>Help will be available for any pupils who have trouble cleaning their hands independently. Skin-friendly cleaning wipes can be used as an alternative. <b>Spreading infection through contact with coronavirus on surfaces</b>	<p>Staff and cleaning staff will regularly clean frequently touched surfaces using standard cleaning products (e.g. detergent), including:</p> <ul style="list-style-type: none"> <li>• Classroom desks and tables</li> <li>• Bathroom facilities (including taps and flush buttons)</li> <li>• Door and window handles</li> <li>• Furniture</li> <li>• Light switches</li> <li>• Reception desks</li> <li>• Teaching and learning aids</li> <li>• Books and games and other classroom-based resources</li> <li>• Computer equipment (including keyboards and mouse)</li> <li>• Sports equipment</li> <li>• Hard toys</li> <li>• Telephones</li> <li>• Outdoor play equipment</li> </ul> <p>Pupils and parents/carers will be asked to limit the amount of equipment they bring into school each day to essentials like bags, lunch boxes, hats, coats, books, stationery and mobile phones.</p> <p>Areas of the school that are used by pupils will be cleaned thoroughly at the end of the day by the school cleaners.</p>	<ul style="list-style-type: none"> <li>• One of the school cleaners will clean the bathroom facilities (including taps and flush buttons) during the lunch break.</li> <li>• Classroom staff will wipe down their own classroom surfaces at intervals during the school day, including morning break and lunchtime.</li> <li>• Office staff will clean the telephones, buzzer handset, photocopier and keyboard/mouse after use.</li> </ul>	<p>Staff Pupils Cleaning staff</p>	<p>From 8<sup>th</sup> March 2021</p>

	<p>Areas of the school not in use will be shut off to make cleaning more manageable.</p> <p>Any resources shared between groups, such as sports, art and science equipment, will be either:</p> <ul style="list-style-type: none"> <li>• Cleaned frequently and meticulously, and always between groups using them; or</li> <li>• Rotated so they can be unused and out of reach for 48 hours (72 hours for plastics) between use by different groups</li> </ul> <p>The same rules will be followed for books and other shared resources that pupils or staff take home. However, unnecessary sharing will be avoided, especially where it doesn't contribute to pupil education and development.</p> <p>Individual and very frequently used equipment, like pens and pencils, will not be shared. Pupils have their own stationary packs,</p> <p>Therapy equipment, such as sensory equipment, will be cleaned between each use. If this is not possible or practical, it will be:</p> <ul style="list-style-type: none"> <li>• Restricted to one user; or</li> <li>• Rotated so it can be unused for 48 hours (72 hours for plastics) between use by different individuals</li> </ul> <p>Shared rooms, such as halls and dining areas, will be cleaned between different groups using them.</p>

<p>If a person with coronavirus symptoms comes into school, a deep clean will take place in the areas that the person has been in, following <a href="#">decontamination guidance</a>.</p> <p>Cleaning supplies will be topped up regularly and monitored to make sure they're not close to running out.</p> <p>Teachers will wash their hands and surfaces before and after handling pupils' books.</p>

<p><b>Spreading infection due to excessive contact and mixing between pupils and staff in lessons</b></p>	<p>To minimise contact, pupils will be kept to their class groups.</p> <p>Children in the EYFS will be kept in consistent groups based on their age groups, while adhering to the usual staffing ratios.</p> <p>Where pupils are old enough and capable enough, they will be taught and reminded to maintain their distance and not touch staff or peers.</p> <p>Pupils will be seated side-by-side and facing forwards, and unnecessary furniture will be moved out of classrooms to allow for this.</p> <p>We will keep pupils in their groups for most of the classroom time, but will allow mixing in wider groups where necessary (e.g. to deliver specialist teaching).</p> <p>We will follow the government's</p>	<ul style="list-style-type: none"> <li>• <b>Pupil groups</b> – the same principles apply but there's more detail on what you should consider to help you decide on your group sizes</li> <li>• <b>Music, dance and drama</b> – you still shouldn't host any performances with an audience</li> <li>• <b>Team sports</b> - if you're considering offering team sports, you should only consider those sports whose national bodies have developed guidance, such as sports on the list available <a href="#">here</a>. [guidance](#) for lessons involving drama, singing, chanting, shouting or playing instruments (particularly wind or brass instruments). These will take place outside wherever possible. If taking place inside, larger, well-ventilated rooms will be used and the number of people will be limited to allow for social distancing.

Any background or accompanying music will be kept to levels which don't require teachers or other performers to raise their voices if they don't have to. Microphones will be used to avoid the need for shouting or prolonged periods of loud speaking or singing. Where possible, microphones, instruments or other equipment won't be shared.

During music lessons and performances, pupils will be positioned either back-to-back or side-to-side at an appropriate distance. Singing or instrument playing will **only** take place in assemblies if there's enough natural airflow and space to allow for strict social distancing between each person (at least 10l/s/person natural airflow for all present, including audiences).

We will not host performances with an audience.

For physical activity, we will follow the same guidance for cleaning equipment and grouping pupils as in all areas of the school. Outdoor sports will be prioritised where possible - where it is not, we'll use large indoor spaces with sufficient ventilation. Distance between pupils will

<p>be maximised as much as possible.</p> <p>For team sports, we will follow the <a href="#">government guidance on team sport</a>. We will not compete with other schools until wider grassroots sport for under 18s is allowed.</p> <p>Staff can work across different groups in order to deliver the school timetable, but they will keep their distance from pupils and other staff as much as they can (ideally 2 metres apart). This won't always be possible, particularly when working with younger children, but close face-to-face contact will be avoided, and time spent within 1 metre will be minimised.</p> <p>Any pupils with complex needs or who need close contact care will have the same support as normal as distancing isn't possible here. Staff will be rigorous about hand washing and respiratory hygiene.</p> <p>Supply teachers, peripatetic teachers and other temporary staff and volunteers will be told to minimise contact and maintain as much distance as possible from other staff. These staff will also participate in the school's rapid testing programme, as outlined for other staff/pupils above.</p> <p>Specialists, therapists, clinicians and other support staff for pupils with SEND should provide interventions as usual. These staff will be advised to be rigorous about hand washing and respiratory hygiene.</p>

<p><b>Spreading infection due to excessive contact and mixing between pupils and staff around and outside of the school</b></p>	<p>Pupils will be kept in the same groups at all times each day, and be kept separate from other groups.</p> <p><i>Note: some mixing will be necessary, such as for specialist teaching).</i></p> <p>Staff and visitors will be asked to wear face coverings in areas of the school where social distancing isn't possible, such as corridors and communal areas, unless they're exempt from wearing one. They'll be given clear instructions about how to put on, remove and store/dispose of face coverings safely.</p> <p>For more detail about our arrangements for face coverings, see the control measures above for the hazard 'Contact with coronavirus when getting to and from school'.</p> <p>Pupils who routinely attend other settings on a part-time basis, such as an alternative provision setting, should be able to continue attending both settings. The school will work with these other settings to work out a system to keep these pupils safe.</p> <p>Pupil groups will have staggered timetables, including for start and finish times, break and lunch times, and assemblies, to avoid too many pupils being in one place at the same time. <i>(see accompanying document detailing timings)</i></p> <p>Movement around the school site will be kept to a minimum to avoid creating busy corridors. 	<p>access to the school library, Hedgehogs and the Multi-Use Room under supervision. Access to the playground will be around the outside of the school.</p> <p>Pupils will be supervised at all times to ensure mixing between groups doesn't occur, and they will be reminded about the rules throughout the day.</p> <p>All shared rooms, such as sport halls and dining areas, will be cleaned between each use.</p> <p>Toilet use will be managed to avoid crowding.</p> <p>Extra staff rooms have been created and staff use of staff rooms and offices will be staggered to limit occupancy.</p> <p>We will limit the number of visitors to the site, where possible. If it is not, visitors will have guidance on physical distancing and hygiene explained to them on or before arrival. Visits will happen outside of school hours wherever possible. We will keep a record of all visitors. 	<p>measures will be in place for this.</p> <p>We are running breakfast and after-school provision, we will try and keep pupils in their same groups where possible, but if that's not possible then we will try to stick to small, consistent groups.</p>

<b>Spreading infection due to the school environment</b>	<p>Checks to the premises will be done to make sure the school is up to health and safety standards.</p> <p>Fire, first aid and emergency procedures will be reviewed to make sure they can still be followed with limited staff and changes to how the school space is being used.</p> <p>This will include checking that all fire doors are operational at all times, and that the fire alarm system and emergency lights have been tested and are fully operational.
